The interested applicants are invited to appear in a walk-in interview through Video Conferencing (VC) mode (the invite will be sent by email one day before the date of the interview) to be held at IIT Jammu for the post of **Electrical Quality Assurance Engineer** to work on the Third Party Quality Assurance (TPQA) of Electrical & Mechanical works of AIIMS Jammu project in Vijaypur, Jammu. The staff will be appointed for two years (on contract) or up to the duration of the project, whichever is earlier. Every year staff performance will be evaluated by the PI and the contract extended accordingly.

Educational qualification and essential skills:

- a) B. Tech. in Electrical Engineering with 55% aggregate marks or 6.5 CGPA.
- b) Candidate should have desirable Electrical Equipment Installation or Maintenance experience.
- c) Candidate must be able to read both Electrical and HVAC drawings and familiar with site management, quality assurance checks, etc.
- d) The candidate should have at least 2-4 years of experience in a quality assurance environment required.
- e) Age limit is 35 years for the general category and for SC/ST/OBC/ Women/PH age limit may be relaxed as per GoI norms.
