The Project Assistant will be appointed initially for 3 months (**on contract**) or upto the duration of the project, whichever is later.

Eligibility for appearing in the walk-in interview:

- First class Bachelor degree in Chemistry (B.Sc. or equivalent) with at least two years of experience in organic synthesis.
- or
- First class Master degree in Chemistry (M.Sc., M. Tech. or equivalent).

Duly filled application form along with the requested details, scanned copies of certificates, other supporting documents, including the letter of experience, should be uploaded through the online portal (<https://apply.iitjammu.ac.in/#/home>) latest by **August 7th, 2021**. Please apply through the [contract/project staff/JRF/SRF] tab on the referred application portal. Candidates who are already employed should produce a relieving certificate from their employers if selected. The interview will be conducted for all shortlisted candidates.

Attention:

1. The applicant will be responsible for the authenticity of the information, other documents, and photographs submitted.
2. Merely possessing the prescribed qualification does not ensure that the candidate would be called for an Interview. The candidates may be shortlisted based on merit and need for the project.
3. Shortlisted candidates will be informed by e-mail about the interview. So, the candidate must provide valid e-mail IDs, phone number information in their applications.
4. Shortlisted candidates must present themselves for the interview on the interview date with an updated CV and original and attested photocopies of mark sheets/ certificates in support of their academic qualifications. Only shortlisted candidates will be called for the interview.
